Hundreds of Area Lawyers and Law Offices Gear Up for Annual Clothing Drive to Benefit DC Area Homeless

Washington, DC, November 23, 2010 – As the number of homeless people and families in the DC area increases, so do the efforts of area lawyers and law offices to provide them with warm clothing. Gifts for the Homeless, Inc. (GFTH), the non-profit, all-volunteer organization supported by the region’s legal community, is now collecting used clothing as part of its annual clothing drive that, for more than 20 years, has distributed *tens of thousands* of bags of used clothing to shelters in the District, Virginia, and Maryland.

“The clothing we collect each year is delivered to more than 70 area shelters, from an 8-bed home for men with AIDS to a 1,600 bed facility serving men, women and children,” said Bart Epstein, President of GFTH. “Every year, we meet the needs of more and more homeless people and families by delivering warm clothing to increasing numbers of shelters and soup kitchens. We intend to serve every facility in the region that helps the homeless -- from emergency shelters to transitional shelters to shelters for battered women and children to soup kitchens. Any shelter or soup kitchen in the area with needs should let us know so that we can do our best to meet their needs.”

During the weekend of December 3-5, several hundred volunteers are coming together to sort, categorize, repackage, and then deliver thousands of bags of donated clothing, blankets, and other necessities to dozens of area shelters to distribute to the homeless. Once again this year, Republic Properties has generously donated the use of its “Portals III” building (D St. SW, between 12th and 13th) for this event. Many parents will bring their school-aged children to have a hands-on experience helping others.

About GFTH: GFTH was created in 1986 by Washington, DC lawyers as part of an effort to give back to the city during the holiday season. Over the years, GFTH has grown into a year-round operation that collects used clothing and monetary donations (used to purchase new clothing such as socks, sweatshirts, long underwear, blankets, hats and gloves). Fundraising for the purchase of new clothing continues throughout the holiday season in an effort to help GFTH meet the increased need resulting from the economic recession. During the 2009-2010 campaign, over 250 volunteers helped GFTH sort and distribute more than 3,333 bags of used clothing for DC’s homeless to 78 shelters and soup kitchens. GFTH also collected nearly \$275,000 in donations and purchased more than 128,000 items of new clothing (including 1,400 blankets) for 35 area shelters and soup kitchens. Of the nearly \$275,000 collected, more than \$130,000 was raised at GFTH’s annual summer concert, known as “Banding Together: Battle of the Law Firm Bands.”

GFTH is wholly volunteer-run by lawyers, legal staff, and other DC area professionals, and receives donations and assistance from individuals at area law offices, government agencies, and associations. Contributions to GFTH are exceptionally effective because 100% of money received is used to purchase items for the homeless at bulk discount. All of the organization’s overhead is covered by participating law offices, organizations, and the individual members of GFTH’s Board of Directors.
